- (c) Provide any two UN Human Rights Conventions held which addressed General human rights, racial discrimination and the rights of Women and Children issues (1 mark)
- (d) Many regional environmental issues require regional rather than global responses
- (i) Highlight the European Union (EU) two key general principles on the Environment (2 marks)
- (ii)Describe two ways North American Free Trade (NAFTA) encourages compliance with domestic law (4 marks)
- (e) Define global governance. (2 marks)
- (f) Explain the term 'Authority' as defined by Avant, Finnemore and Sell. (2 marks)
- (g) Identify the five bases of authority in global governance (5 marks)
