Mary is very jealous of Elina and tells Mrs Mjomba, who is not around the office very often, that Elina has been coming late to work everyday for the last one month and has also been sending clients to other travel agents where her friends work. This is actually not true as Elina is a very hardworking and loyal employee. However, Mrs Mjomba believes Mary because Mary is her personal assistant who has worked for her for a very long time and has helped her get rid of many bad employees in the past. Mrs Mjomba feels that she has a moral obligation to inform Mrs Pesa of Elina's alleged misconduct. Mrs Mjomba fires Elina and Mrs Pesa refuses to employ Elina after getting the negative information about Elina from Mrs Mjomba. Advise Elina.

#### Question 2

(a) Explain the advantages and disadvantages of case law.

(b) Moses and Peter are neighbors in an upmarket Nairobi estate. They have had a long going argument concerning the fence that divides their properties. Moses claims that three years ago Peter moved the fence and encroached on his property. Moses sued Peter but lost the case and ended up paying hefty legal fees. Moses has openly been heard to declare that he hates Peter so much that he would not mind if he died. One Sunday evening Peter's house caught fire and Peter was trapped inside. His cries for help were heard by Moses. Moses walked out of his house, saw what was happening and calmly walked back to his house saying to himself 'I am not going to help him. Let him die'. Peter was eventually rescued by a good Samaritan who was passing by. The good Samaritan had called the fire brigade who promptly came and rescued Peter in the nick of time. Peter suffered serious burns and was hospitalized for over three months. His hospital bill came to over Kshs 300,000 and he is unable to use his right hand. He wants to sue Moses to recover his hospital bill as well as for damages for pain and suffering because he claims that if Moses had rescued him at the time he heard his screams he would not have suffered any injury at all.
